

#### **GREAT START READINESS PROGRAM**

The Great Start Readiness Program (GSRP) is a FREE program funded by the Michigan Department of Education. The program runs Monday-Thursday with half day and full day options available. Students must be 4 years old on or before September 1, 2023. Additionally, specific eligibility requirements must be met to be enrolled.

### EARLY CHILDHOOD SPECIAL EDUCATION PROGRAM

The ECSE program is designed to meet the needs of a special group of students who qualify. This program is free and begins on Wednesday, September 6th. An Individualized Education Plan (IEP) is required to qualify. The program runs four to five days per week, AM or PM sessions,



### YOUNG 5'S PROGRAM

We are excited to offer a Young 5's program to students who will be five years of age between July 1 and December 1. The Young 5's program is a bridge between Preschool and Kindergarten providing young learners the opportunity to learn and grow in an environment that is tailored to meet their academic and social needs. We are excited to implement curriculum that encourages curiosity and scientific exploration, promotes early literacy and math skills and teaches the social emotional skills students need for a successful academic career.

### AFTER SCHOOL PROGRAMS AVAILABLE

Fitzgerald High School is excited to partner with Wayne State University this year to offer the C2 Pipeline program. C2 Pipeline is open to students in grades 9-12. After school sessions run for two and a half hours daily, Monday through Thursday. During these two and a half hours, students are served dinner or a snack and also have a chance to participate in academic center and enrichment. C2 Pipeline's academic center offers students the opportunity to receive assistance with homework, projects, and any school related work in a small group setting. Enrichments cover topics that would not normally be covered during the school day in a fun and exciting, hands on atmosphere. Examples include: Anatomy in Clay, Fashion Engineering, Traumatic Brain Injury, Need for Green Speed, SAT Prep, STEM Busters, and Empowerment Improv. Each center considers district goals and school improvement plans when determining programming activities. All enrichment curriculum is aligned to Common Core State Standards, Next Generation Science Standards, and state curriculum standards. Applications are available in the main office or online. All students are accepted!



### ACCELERATED LEARNING OPPORTUNITIES FOR FHS STUDENTS

#### **DUAL ENROLLMENT**

This program provides students who qualify the opportunity to attend courses at local colleges and universities to earn both high school and college credit. Fitzgerald Public Schools will pay (up to a state specified amount) for qualified students to enroll in classes at a college or university of their choice. Acceptance into a Dual Enrollment program is based on qualifying scores on standardized tests such as the PSAT and SAT. Students who choose to dual enroll will be taking a total of six courses, which will be a mix of classes at Fitzgerald High School and the college/university of their choice. FHS students will be taking a PSAT/SAT in October 2023 and can qualify based on their scores on the assessment they take.

#### EARLY COLLEGE OF MACOMB

The Early College of Macomb (ECM) is a program for high school students that will give them an early start toward career and higher education opportunities. The ECM provides eligible students with the opportunity for 11th grade students to enter a college program while still in high school. They benefit from a curriculum that enables them to earn their high school diploma and attend a 13th year of school after graduation, earning an Associate Degree with no cost to themselves for tuition, fees and books. Early College of Macomb students attend FHS classes, as well as career-focused classes on the Macomb Community College campus. Students engage in an exciting curriculum taught by both high school and college instructors that will move them ahead of a traditional schedule toward degrees of technical certificates that match the students' chosen career pathways, Students must apply for acceptance to the ECM in their 10th grade year. If your student is going into 9th or 10th grade and is interested in this program, please have them speak to their counselor.

The Fitzgerald Health Center is part of the Henry Ford Health System's Department of Pediatrics, School-Based and Community Health Program. Services are provided to youth through 21 years old regardless of insurance status or ability to pay. A signed consent form is required for your child to receive services. We are not a replacement for your primary care provider, but serve as a convenient alternative to support your healthcare needs. There are no out-of-pocket costs. If your family needs health insurance, we can provide insurance application assistance at the health center. The health center provides treatment of minor illness and injury, physical exams, immunizations and vaccinations, health education and laboratory testing. All services are confidential. We also provide mental health services including individual counseling.

#### Drug-Free Schools and Communities Act of 1996 (Amends Michigan Public Health Code Public Act 174 of 1994)

The drug-free zone surrounding school property is 1,000 feet. Any individual who delivers cocaine, narcotics, or other illicit substances to a minor student within the 1,000-foot drug free zone around school property shall be punished by at least two years in prison and up to three times the term of imprisonment and fine or both that would otherwise apply. "School Property" is defined as a "building, playing field, or property used for school purposes to impart instruction to children in grades kindergarten through 12, when provided by a public, private, denominational, or parochial school, except those buildings used primarily for adult education or college extension courses."

#### **Pest Management Program Notification**

As part of the Fitzgerald Public School District's Pest Management Program, pesticides are periodically applied to school property. Planned applications will be posted at building entrances at least 24 hours prior to application. In certain emergencies, pesticides may be applied without prior notice, but if requested, you will be provided notice following any such application. #### Annual Notification of Asbestos Hazard Emergency Response Act (AHERA)

Fitzgerald Public Schools conducted major asbestos abatement within Fitzgerald High School this summer. Materials removed included, but are not limited to, floor tile, pipe insulation, and ceiling materials. The Asbestos Hazard Emergency Response Act (AHERA) was passed in 1986. District buildings are monitored every six months and re-inspected every three years to comply with AHERA regulations. Our next re-inspection is scheduled for April 2024. Fitzgerald Public Schools may conduct minor asbestos abatement within its facilities in the next year. When asbestos is disturbed in our District, it is performed by Michigan Licensed Asbestos Abatement Contractors and managed by Nova Environmental, Inc., the district's environmental consulting firm. Questions relating to asbestos-related issues can be addressed to Fitzgerald Public Schools, Facilities Dept., 23200 Ryan Rd, Warren, MI 48901.

#### **Board Policy Controls Release of Records**

Fitzgerald Public Schools has compiled student records for use in providing appropriate educational programs and services. Management and use of these records and access to them is controlled by Board of Education policy, state and federal legislation. All parents and guardians of students under age 18 and all students age 18 or older have a right to review the official school records, which relate directly to their student or themselves. They also have a right to limit the disclosure of these records and to request changes to ensure accuracy and fairness. For further official student records information, contact building principals.

Fitzgerald Public Schools has designated the following as directory information to be disclosed to nonprofit organizations and governmental agencies without prior written consent:

- Names of parents
- Student's date of birth
- Class (first grade, etc.)
- Student's photograph

Parents, guardians and/or eligible students have two weeks after the publication of this notice to advise the Superintendent in writing of any items they do not want designated as directory information. Address inquiries to: Office of the Superintendent, Fitzgerald Public Grievance Procedures for Title VI of the Civil Rights Act of 1964, Title IX of the Education Amendment Act of 1972, Title II of the Americans with Disabilities Act of 1990, Section 504 of the Rehabilitation

Section I: Any person believing that the Fitzgerald Public School District or any part of the school organization has inadequately applied the principles and/or regulations of (1) Title VI of the Civil Rights Act of 1964. (2) Title IX of the Education Amendment Act of 1972. (3) Title II of the Americans with Disability Act of 1990. (4) Section 504 of the Rehabilitation Act of 1973, and (5) the Age Discrimination Act of 1975 may bring forward a complaint, which shall be referred to as a grievance, to the local Civil Rights Coordinator at the following address: Regan Galloway,

Fitzgerald Public Schools, 23200 Ryan Road, Warren, MI 48091 or call (586) 757-1751.

Section II: The person who believes a valid basis for grievance exists shall discuss the grievance informally and on a verbal basis with the Civil Rights Coordinator, who shall in turn investigate the complaint and reply with an answer within (5) business days. The complainant may initiate formal procedure according to the following steps:

Step 1. A written statement of the grievance signed by the complainant shall be submitted to the local Civil Rights Coordinator within five (5) business days of receipt of answers to the informal complaint. The coordinator shall further investigate the matters of grievance and reply in writing to the complainant within five (5) business days.

Step 2. A complainant wishing to appeal the decision of the local Civil Rights Coordinator may submit a signed statement of appeal to the Superintendent of Schools within five (5) business days after receipt of the coordinator's response. The superintendent shall meet with all parties involved, formulate a conclusion, and respond in writing to the complainant within ten (10) business days.

Step 3. If unsatisfied, the complainant may appeal through a signed, written statement to the Board of Education within five (5) business days of receiving the superintendent's response in Step 2. In an attempt to resolve the grievance, the Board of Education shall meet with the concerned parties and their

representative within fifteen (15) days of the receipt of such an appeal. A copy of the Board's disposition of the appeal shall be sent to each concerned party within (1) days of this meeting.

Inquiries concerning nondiscriminatory policies may be directed to Director, Office for Civil Rights, Department of Education, Washington, D.C. 20202, or Regan Galloway, Fitzgerald Public Schools, 23200 Ryan Road, Warren, MI 48091. A copy of each of the Acts and regulations may be found in the local Civil Rights Coordinator's office.
